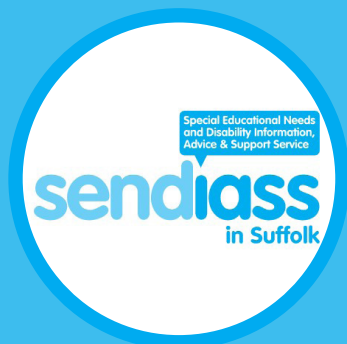

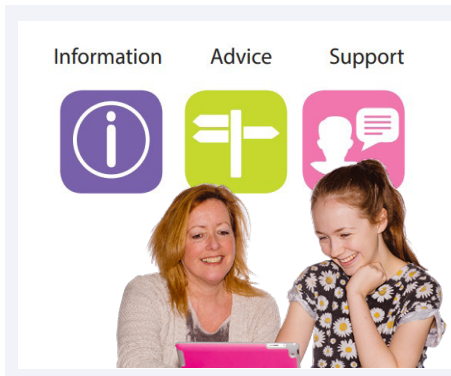

You might like to have support from Suffolk SENDIASS.

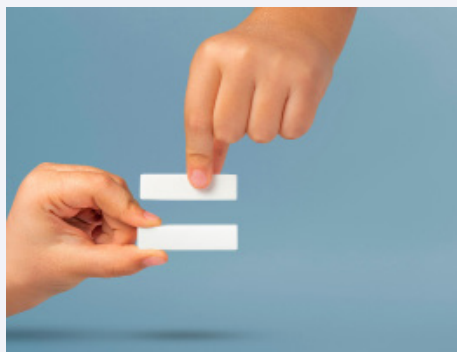


Suffolk SENDIASS stands for:

SENDIASS is a free service for children and young people with special educational needs or disabilities and their parents and carers.



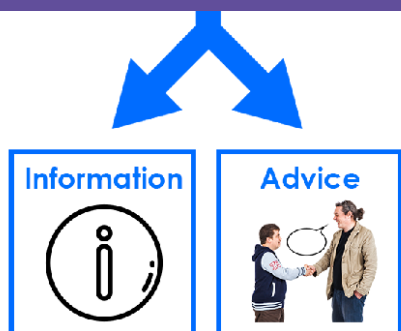
We are impartial and do not take sides.



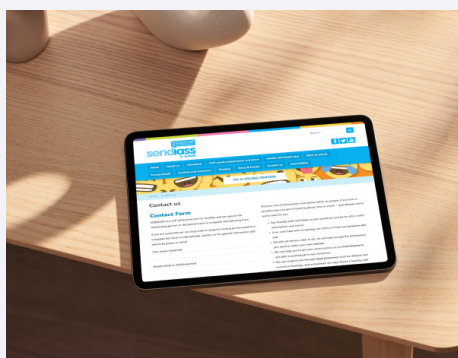
We will help you get the information you need to make your own choices.

If this is what you want us to do;

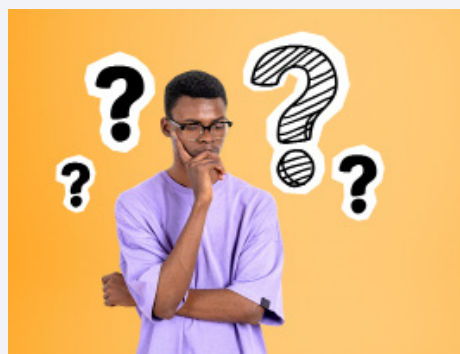
Keeping people safe

This is not the same as statutory advocacy.



Statutory advocacy is for some situations when you have a legal right.

Listen to your views and concerns.



Help you to understand your rights in relation to Special Educational Needs and Disability.



Help you to really understand the decisions you are making.



Help to put you in touch with other services.



We might support you at meetings or appointments.



In meetings or appointments we can help you to:



Share your views



Make sure you understand everything



Help you to speak up and ask questions

Give our own personal opinion.



Take away your problems and make decisions for you.



Make judgements about you.



We don't...



Have the power to make a school or service to do something.

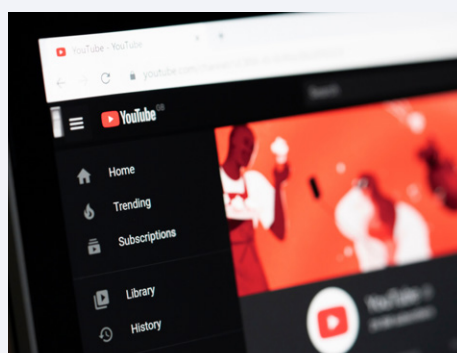
